Jackson Fisher, Friends of Riverside Park

- BCRP and the City are looking to put in an EV charging station on Johnson St by TJEMS, just north of the staircase on the west entrance of the park. Expected sometime this fall.

Rachel Wagner, Public Safety

- 3 arrests were made, including 2 juveniles and 1 adult, police believe could be related to burglaries over the summer. While burglaries seemed to slow, there was one more Saturday 23rd at 3am.
- Reminder to deliver packages to Amazon Locker, other business, or neighbor with a vestibule.
- Rachel is working with a larger local neighborhood safety committee including other neighborhood groups and they are willing to support local crime victims as needed and requested, e.g. talking through next steps, options

- Rich is hoping to get in touch with Planning Dept to be aware of things coming our way.



MHAM advocates for mental health, behavioral health, and addiction policies. Numbers of these types of events/crises are higher than ever in the last year.

MHA is working on agenda setting for years ahead and wants to get perspectives from communities across the state of MD. In the lead up to the gubernatorial race next year, they want to build their policy agenda and campaign.

They have been working with BPD, they have Crisis Intervention Teams that get called rather than calling Police. You can call 211 to reach these services. There will also be a national number next year, which will be 988. This is intended to help lower criminalization of mental health crises or events.

Question: (Jeff Kaplan) What about training for BPD regarding behavioral/mental health crises to protect lives?

Shannon Sullivan (next speaker) replied that policies and training have been updated as part of the Consent Decree at the federal level; a reminder that even when BPD tries to divert people in behavioral health crisis, there aren't always services available to divert them to and this is still a work in progress.

Derrell confirmed that MHA works and comments on policy, training, and advocacy but doesn't implement the policies or directly train BPD. They work on advocacy at the MD state level.


Shannon Sullivan, Consent Decree Implementation Unit at BPD

What is the Consent Decree? Federally (DOJ) mandated police reform including changes to policy, training, and accountability systems. This is not aligned with any political leaders but comes from the Department of Justice and is overseen by federal judge James Bredar with assistance from a Monitoring Team of experts.

Consent Decree is in Year 4 now. A lot of this is about culture change and sustainable change so it doesn't happen overnight. The process is Policy > Training > Implementation. Baltimore is largely in the Implementation phase now.
